**Notice Inviting Tenders**

1. Tenders are hereby invited for the work of “**Extension of First Floor North West of Canteen at IICT, Hyderabad**” from Civil contractors of appropriate class of CPWD, Railways, MES, Post & Telegraph Department and / or from those who have carried out Similar works for CSIR and Semi-Govt. Organizations amounting to **Rs.25,22,175=00 (Rupees Twenty Five Lakhs Twenty Two Thousand One Hundred and Seventy Five only)** and above. The tenderers are required to produce proof of fulfilling these conditions of labour license, VAT registration along with latest Income Tax Clearance Certificate while making request for issue of tender documents. Originals are to be produced while issuing tenders.
2. Estimated cost is **Rs.25,22,175.00 (Rupees Twenty Five Lakhs Twenty Two Thousand One Hundred and Seventy Five only)**. Time for carrying out the work will be **45 days** and the date of commencement shall be reckoned from the tenth day of issue of award letter.
3. Complete contract documents to be complied with by the tenderer whose tender may be accepted can be seen at Office of **Head, ESD**.
4. Tenders should be on the specified form (Non-transferable) which may be obtained from the Office of Civil Engineering Services during office hours on payment of **Rs.500/-** (Rupees Five hundred only) at Cash Section (Non-refundable) in favour of Director, IICT, Hyderabad at IICT from **03/03/2017 to 10/03/2017**.
5. Tenders should be submitted in double sealed covers superscribed with the name of the work, date and time of opening written both on the inner and outer envelopes. They will be received up to 2.30 P.M on **13/03/2017** and will be opened at 3.00 P.M on **13/03/2017** in the office of AO, IICT. Tenders should be dropped in the tender box before the closing date and time indicated. In case these are sent by post they should be sent by Regd. Post/speed post addressed to AO, IICT. Tenderers are to ensure that they post the tender well in advance so as to reach before the closing time and date indicated.
6. The Earnest money amounting to **Rs.50,445.00 (Rupees Fifty Thousand Four Hundred Forty Five only)** as Demand Draft / pay order / Banker’s Cheque of a schedule bank and drawn in favour of Director, IICT should accompany the tender. Tenders received without earnest money will be invalid.
7. The Employer does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.
